PRACTICE REQUIREMENT

2,000 hours in the past 3 years

Hold a current Registered Nurse (RN) license in the U.S., its territories, or Canada

Recommended two years of med-surg practice

**Additional requirements may apply for international candidates.*

EXAM FORMAT AND TIME

150 questions; 3 hours

RECERTIFICATION

Every 5 years by examination or continuing education

FOCUS

Virtual nursing in acute-care hospitals

PRACTICE REQUIREMENT

1,000 hours in the past 2 years

Hold a current Registered Nurse (RN) license in the U.S.

**Practice hours may include clinical nursing, management, or education.*

EXAM FORMAT AND TIME

120 questions; 2.5 hours

RECERTIFICATION

Every 5 years by examination or continuing education

FailSafe is an employer-purchased certification support program that helps organizations invest in nurse certification while reducing financial risk.

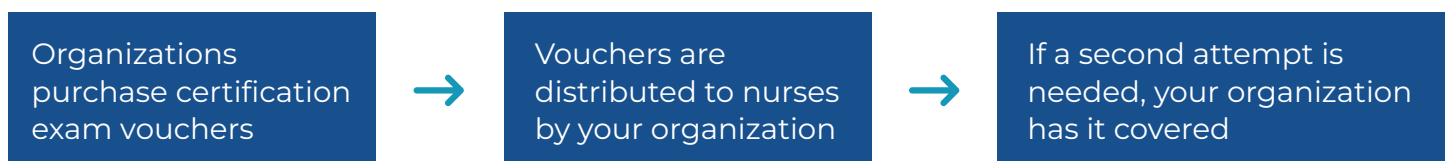
What FailSafe Does

CertAssure™ is MSNCB's certification support program designed to help nurses pursue CMSRN or CAVRN certification with reduced financial risk and added peace of mind.

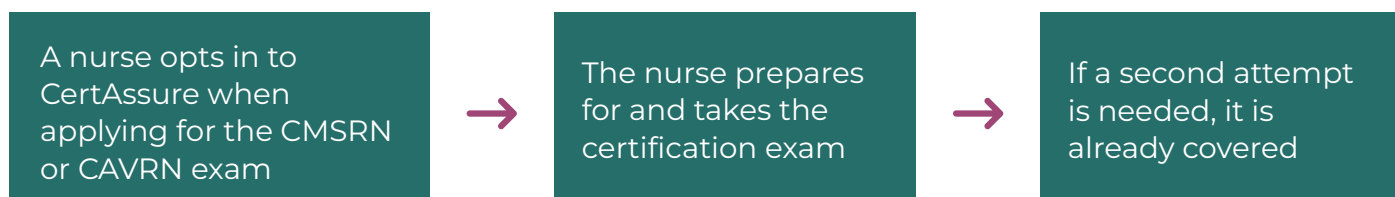
What CertAssure Does

Frequently Asked Questions

Who is eligible to pursue MSNCB certification?

Eligibility varies by certification and includes current RN licensure and required practice hours.

How do I prepare for the certification exam?

MSNCB provides exam blueprints, candidate handbooks, and recommended preparation resources for each certification. Visit the [CMSRN](#) and [CAVRN](#) resource pages to learn more.

Is financial support available for certification or recertification?

There are several ways to obtain financial support. Applying for one of AMSN's [CMSRN Certification or Recertification Grant](#) can offset costs, and purchasing CertAssure or encouraging your organization to support FailSafe can help with CMSRN and CAVRN certification and recertification.

Are certification support programs required?

No. Certification support programs such as [FailSafe](#) and [CertAssure](#) are optional tools designed to provide added confidence and financial protection.

How long is certification valid?

Certification is valid for five years and requires recertification to maintain active status.

Are resources available for recertification?

Yes. MSNCB provides recertification guidance and tools for [CMSRN](#) and [CAVRN](#) to support nurses in maintaining their credentials.

Certification Checklist

- ☐ Download the CMSRN[®] or CAVRN[®] Certification Handbook.
- ☐ Check if you meet the eligibility requirements.
- ☐ Consider CertAssure[™] or approach your organization about enrollment in FailSafe.
- ☐ Submit your application.
- ☐ Get familiar with the CMSRN or CAVRN Exam Blueprint.
- ☐ Identify your study priorities and prepare your study plan.
- ☐ Schedule your exam.
- ☐ Review testing policies and test day procedures to prepare for your exam day.
- ☐ Show up to your exam appointment 30 minutes early – you got this!

Recertification Checklist

- ☐ Download the CMSRN or CAVRN Recertification Handbook.
- ☐ Review the recertification requirements and pick your pathway.
- ☐ Ask your organization about applying FailSafe to your recertification.
- ☐ Take the exam or enter your continuing education credits before the end of your five-year certification period.
- ☐ Submit your application to recertify!
